## **NATIONAL FISH CONSUMPTION DAY 2019 TERMS & CONDITIONS**

**28 SEPTEMBER 2019**

### **1. DEFINITIONS AND GENERAL**

- The Terms & Conditions set out herein shall be read and construed as an integral part of the contract. In these present Terms and Condition, the term "Exhibitor" shall include all staff or individual to whom space has been allocated for the purpose of exhibiting. The term "Exhibition" shall mean the Exhibition(s) referred to on the application form, the term "Organizer" shall mean NFCPT and the term "Contract" shall mean the contract for Exhibition space at the Fish Market, entered into between the Organizer and the Exhibitor and which incorporate the present Terms and Conditions which shall be construed as an integral part of the contract.
- The Organizer reserves the right to accept or refuse any application without disclosing to the Exhibitor any reason thereof.

### **2. STAND SET-UP AND EXHIBITION**

- Exhibitors should set up their stands on **Friday, 27 September 2019** starting from **14:00**.
- All stands should be ready for exhibition on **Saturday, 28 September 2019** at **09:00**.

### **3. STAND STRUCTURE**

- Mandatory **3x3m** stand will be allocated to all Exhibitors at **NO COST** (expansion to the stand size shall be available upon request).
- Partitioned structured stand will be provided for Exhibitors.
- No music will be allowed by any Exhibitor/s.
- Exhibitors are responsible for cleaning their stand(s) and immediate surroundings before and after the event.
- Selling of alcohol can only be done if the appropriate documentation and permission has been obtained.
- Only portable braais shall be allowed.

- All exhibitors must keep the Conditional Certificate at the event for inspection purposes.

- The Organizer shall have the right to cancel any Exhibitor’s participation in the Exhibition if the said Exhibitor contravenes the regulations in any way, and this without the Exhibitors having any claim to compensation of reimbursement for any of all financial commitments undertaken.
